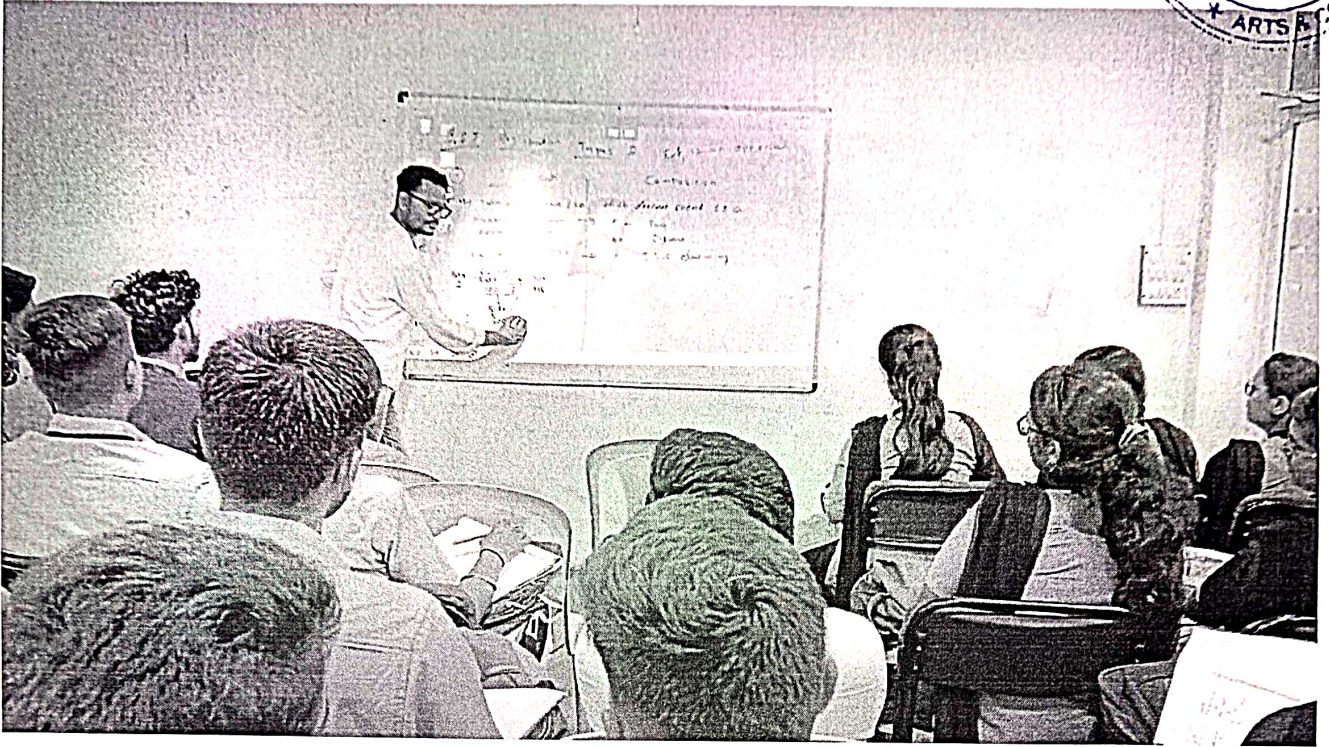
This field visit helps to Students.

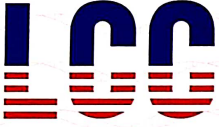

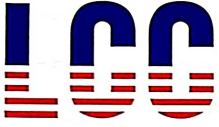
